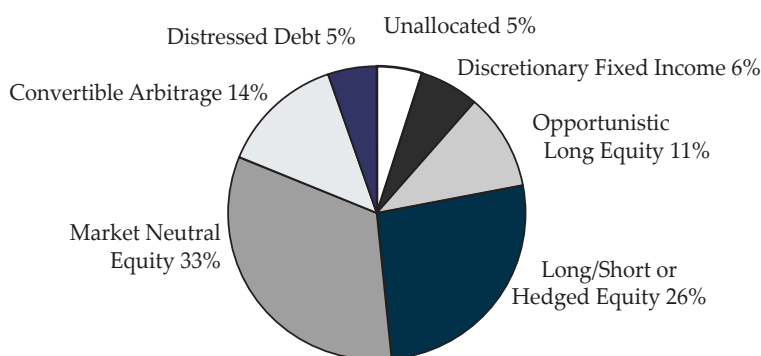
Investment Objective: The Fund seeks to achieve long-term capital appreciation with an emphasis on absolute (positive) returns and low correlation to traditional financial market indices such as the S&P 500. There can be no assurance the fund will achieve its objective.

Investment Parameters: There is no fixed or minimum allocation to any sub-adviser, however, the Adviser will limit allocations to any one sub-adviser strategy to between 0% and 20% of total Fund assets.

Quarter-End Performance: As of 09/30/07, the 1- year and since inception annualized performance for I- Share was 7.31% and 5.56%, respectively. The 1- year and since inception annualized performance for A- Share was 6.92% and 5.19%, respectively. The 1- year and since inception performance for A- Share with sales charge was 2.11% and 2.99%, respectively. The 1- year and since inception performance for C- Shares was 6.12% and 4.50%.

As stated in the current prospectus, the Fund's annual operating expense ratios (gross) for Class I, Class A and Class C Shares are 2.14, 2.45% and 5.40% respectively. However, the Fund's adviser has agreed to contractually waive a portion of its fees and/or reimburse expenses such that total operating expenses do not exceed 1.95%, 2.25% and 3.00% for Class I, Class A and Class C Shares. Although subject to change, this waiver is renewed annually on July 31st.

Returns include the reinvestment of dividends and capital gains. Some of the Fund's fees were waived or expenses reimbursed; otherwise, returns would have been lower.

Portfolio Commentary:

The Fund performed well during a volatile 3rd quarter with a total return of 1.49%, including July and August performance of -0.19% and +0.19% respectively. It's worth noting that the Fund's loss of -0.19% in July is the only down month out of the past 16 months. Quarterly returns for the S&P 500 Index and the Lehman Aggregate Bond Index were 2.03% and 2.84% respectively. There were many dislocations in the quarter that proved to be a great stress test for alternative investments. Many hedge funds lost money, including a quarterly loss of -4.3% for the HFRX Equity Market Neutral Index.

We were not surprised by the recent turbulence. In fact, our previous commentaries articulated our concerns with how loose credit, low risk premiums and leverage would hold up in an environment where credit tightens or liquidity moderates. We have also stated concerns for investors who attempt to diversify portfolios and find broad asset correlations and sensitivities that include many hedge fund strategies.

Even though hedge fund volatility made headlines during the quarter, investors should not panic if their fund is down 1-2% for the month when the S&P 500 is up; that's "uncorrelated." The problem (that justified our on-going concern) is that many hedge funds (and investment banks) have relied on easy credit, low volatility and excessive use of leverage to generate performance. Up until recently, this undisciplined approach had created a panacea of incredible returns with low volatility. Unfortunately, low volatility does not mean low risk, especially when using illiquid investments that are not marked to market, but marked to a model. When highly levered portfolios are not valued appropriately, a dislocation is inevitable when conditions change (and they sure did!). As a result, many market participants were forced to liquidate and de-lever their portfolios which dealt their investors sizable losses (leverage worked in reverse) and generated additional market volatility.

While investors have begun to reassess risk, many investments continue to rely on "Goldilocks" conditions. Investors and advisors would be wise to assess whether their investments "require" leverage or sensitivity to market factors to generate attractive returns. *See reverse for definitions

Portfolio Strategy: We manage the overall portfolio strategy through a quantitative model that focuses on optimizing manager allocations based on performance, risk, correlation and diversification. The investment process monitors manager exposures and return attribution on an ongoing basis. The Fund's investment approach differs from more traditional investments that achieve returns from general market or beta exposures, so its performance and exposures differ accordingly. In addition, our Sub-Advisers are free to selectively take risk, hedge risk, or avoid risk in individual securities or industries without being constrained by focusing on a benchmark.

Definitions: Beta is the measure of a fund's relative volatility as compared to the S&P 500 Index which by definition is 1.00. Accordingly, a fund with a 1.10 beta is expected to perform 10% better than the Index in up markets and 10% worse in down markets. Alpha is the difference between a fund's actual returns and its expected performance, given its level of risk as measured by Beta. The S&P 500 Index is a broad-based, unmanaged measurement of changes in stock market conditions based on the average of 500 widely held common stocks. The Lehman Aggregate Bond Index comprises government securities, mortgage-backed securities, asset-backed securities and corporate securities to simulate the universe of bonds in the market. The DJIA consists of 30 stocks that are considered to be major factors in their industries and that are widely held by individuals and institutional investors. The NASDAQ is an unmanaged index representing the market cap weighted performance of approximately 5,000 domestic common stocks traded on the NASDAQ exchange. The HFRI Indices are equally weighted performance indexes, utilized by numerous hedge fund managers as a benchmark for their own hedge funds. It is not possible to invest directly in an index or average. Standard Deviation indicates the volatility of a fund's total returns. In general, the higher the standard deviation, the greater the volatility of return.

Since the Fund utilizes a multi-manager strategy with multiple subadvisers, it may be exposed to varying forms of risk. The Fund's net asset value and investment return will fluctuate based upon changes in the value of its portfolio securities. The Fund is non-diversified and may focus its investments in the securities of a comparatively small number of issuers. Concentration in securities of a limited number of issuers exposes a fund to greater market risk and potential monetary losses than if its assets were diversified among the securities of a greater number of issuers.

The Fund may invest in small- and medium-sized companies which involve greater risk than investing in larger, more established companies, such as increased volatility of earnings and prospects, higher failure rates, and limited markets, product lines or financial resources.

The Fund may invest in foreign or emerging markets securities which involve special risks, including the volatility of currency exchange rates and, in some cases, limited geographic focus, political and economic instability, and relatively illiquid markets.

The Fund may invest in debt securities which are subject to interest rate risk. An increase in interest rates typically causes a fall in the value of the debt securities in which the Fund may invest. The Fund may also invest in high

yield, lower rated (junk) bonds which involve a greater degree of risk and price fluctuation than investment grade bonds in return for higher yield potential.

The Fund may purchase securities of companies in initial public offerings. Special risks associated with these securities may include a limited number of shares available for trading, unseasoned trading, lack of investor knowledge of the company and limited operating history. The Fund may leverage transactions which include selling securities short as well as borrowing for other than temporary or emergency purposes. Leverage creates the risk of magnified capital losses.
